- You misrepresent information on this application. If ANY misrepresentation is discovered, your rental agreement may be terminated.
- · Your background check includes drug and other criminal activity, convictions, prior evictions and unsatisfied judgements.
- Your credit check shows an unsatisfactory record.
- Any other lawful reason.

### REASONABLE ACCOMMODATIONS

- If a resident, applicant/prospective resident, or someone associated with a resident has a disability, they may make a written request for a reasonable accommodation at any time.   EXCEPTIONS. If pets are found on the premises without approval, they will be required to leave. Pet rules & regulations are
  available upon request.
- I understand that criminal history which indicates that an applicant's tenancy would constitute a direct threat to the health
  or safety of other individuals or whose tenancy would result in substantial physical damage to the property of owner or
  others will result in rejection of the application. Such criminal history may include, but is not limited to, sexual assault or
  other sex related crimes, the sale or manufacture of illegal drugs, crimes against persons, burglary or theft.
- I hereby authorize anyone contacted by Landlord or its agents to release my credit and personal information to them at any time for the purposes of entering into and continuing to offer or collect on any agreement or credit extended.

# **Privacy Policy**

This Privacy Policy describes Our policies and procedures on the collection, use and disclosure of Your information when You use the Service and tells You about Your privacy rights and how the law protects You. We use Your Personal Data to provide and improve the Service. By using the Service, You agree to the collection and use of information in accordance with this Privacy Policy.

# **INTERPRETATION**

The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

### **DEFINITIONS**

- Cookies are small files that are placed on Your computer, mobile device or any other device by a website, containing the details of Your browsing history on that website among its many uses.
- Country refers to: United States
- Device means any device that can access the Service such as a computer, a cellphone or a digital tablet.
- Do Not Track (DNT) is a concept that has been promoted by US regulatory authorities, in particular the U.S. Federal Trade Commission (FTC), for the Internet industry to develop and implement a mechanism for allowing internet users to control the tracking of their online activities across websites.

We will retain and use Your Personal Data to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies. The Company will also retain Usage Data for internal analysis purposes. Usage Data is generally retained for a shorter period of time, except when this data is used to strengthen the security or to improve the functionality of Our Service, or We are legally obligated to retain this data for longer time periods.

### **Transfer of Your Personal Data**

Your information, including Personal Data, is processed at the Company's operating offices and in any other places where the parties involved in the processing are located.   affirmative authorization (the "right to opt-in") from either the Consumer who is between 13 and 16 years of age, or the
  parent or guardian of a Consumer less than 13 years of age. Consumers who opt-in to the sale of personal information may
  opt-out of future sales at any time. To exercise the right to opt-out, You (or Your authorized representative) may submit a
  request to Us by contacting Us.
- If You have reason to believe that a child under the age of 13 (or 16) has provided Us with personal information, please contact Us with sufficient detail to enable Us to delete that information.

# Your Rights under the CCPA

The CCPA provides California residents with specific rights regarding their personal information. If You are a resident of California, You have the following rights:

  exceptions. Once We receive and confirm Your request, We will delete (and direct Our Service Providers to delete) Your

- b) Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity, or prosecute those responsible for such activities.
- c) Debug products to identify and repair errors that impair existing intended functionality.
- d) Exercise free speech, ensure the right of another consumer to exercise their free speech rights, or exercise another right provided for by law.
- e) Comply with the California Electronic Communications Privacy Act (Cal. Penal Code § 1546 et. seq.).
- f) Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when the information's deletion may likely render impossible or seriously impair the research's achievement, if You previously provided informed consent.
- g) Enable solely internal uses that are reasonably aligned with consumer expectations based on Your relationship with Us.
- h) Comply with a legal obligation.
- i) Make other internal and lawful uses of that information that are compatible with the context in which You provided it.
- The right not to be discriminated against. You have the right not to be discriminated against for exercising any of Your consumer's rights, including by:
  - a) Denying goods or services to You
  - b) Charging different prices or rates for goods or services, including the use of discounts or other benefits or imposing penalties
  - c) Providing a different level or quality of goods or services to You
  - d) Suggesting that You will receive a different price or rate for goods or services or a different level or quality of goods or services

# **Exercising Your CCPA Data Protection Rights**

- For data portability requests, We will select a format to provide Your personal information that is readily usable and should allow You to transmit the information from one entity to another entity without hindrance.

# **Do Not Sell My Personal Information**

- You have the right to opt-out of the sale of Your personal information. Once We receive and confirm a verifiable consumer request from You, we will stop selling Your personal information. To exercise Your right to opt-out, please contact Us.
